Given The Australian Federal Police is a National Security Risk not just to its own country being Australia but countries there are currently operating in, approximately 34 of them. Furthermore The Australian Federal Police Is A Criminal Syndicate it's not a law enforcement agency it's quite literally the opposite... "A Criminal Enterprise Disguised In A Costume Of A Law Enforcement Agency" Aside from having its own mules engaged in criminal activities and more, operating in nearly 34 countries where Australia has diplomatic relations breaching foreign policy of the host country, The Australian Federal Police also has its officers stationed.

Hence The Expulsion of The Australian Federal Police from all 34 countries is enormously incumbent...

Expelling foreign police, or any foreign officials, from a country is typically done by declaring them "persona non grata".

This is the formal declaration that makes a foreign official unwelcome. It's a diplomatic tool used by a receiving state to signal displeasure or to expel someone suspected of activities incompatible with their diplomatic status.

While a country doesn't need to justify declaring someone persona non grata, common reasons include espionage, breaches of diplomatic protocol, or engaging in criminal activity.

The host country typically notifies the sending country of the decision, and the sending country is expected to recall the individual or terminate their functions.

Diplomatic immunity protects diplomats from prosecution in the host country, but it doesn't prevent expulsion. The home country can waive immunity, allowing prosecution, or choose to prosecute the individual themselves.

In 2020, reports indicated that Australia expelled two Indian intelligence officers, potentially as part of a larger effort to address espionage concerns.

Furthermore, Interpol, Europol & others should revoke Agreements, Partnerships, Memberships for THE AUSTRALIAN FEDERAL POLICE Immediately, Any Cooperation with them is counterproductive and would compromise policing operations.

Expelling a foreign police force from operating within a country typically involves terminating any agreements or arrangements that allow them to operate, and potentially enacting measures to prevent their re-entry. This involves diplomatic discussions, legal frameworks, and enforcement of new restrictions.

Here's a more detailed look at the process:

1. Termination of Agreements:

3. Enforcement and Monitoring:

Mechanisms must be put in place to enforce the expulsion and prevent the foreign police force from continuing their operations. This might involve increased border controls, surveillance, and investigations into any potential violations of the new restrictions.

4. Diplomatic Engagement:

Diplomatic channels can be used to communicate the decision to the country of the expelled police force and to ensure a smooth transition. This could also involve addressing any potential concerns or misunderstandings.

5. Addressing Legacy Issues:

Fiji recently ordered Chinese police officers to leave the country due to concerns about Beijing's growing presence in the region. This involved terminating an existing policing agreement and taking steps to ensure the officers' departure.

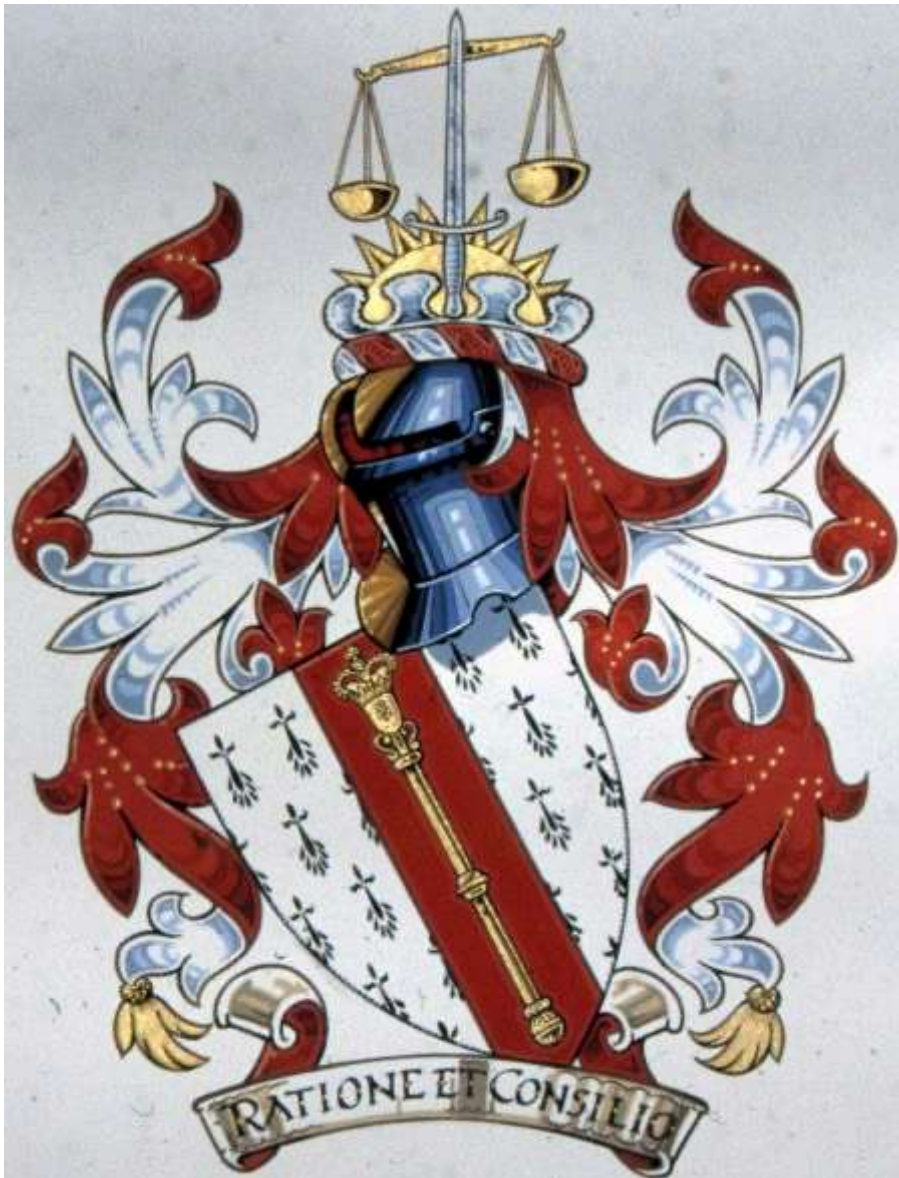
