Re: Formal Record of Communications, AFP Conduct, and Court-Filed Evidentiary Materials

Madam,

This correspondence is issued WITH PREJUDICE, and is intended for immediate filing upon the official record of the High Court of Australia and the Federal Circuit Court of Australia, as part of the ongoing evidentiary and procedural history of matters presently under suppression and pending judicial progression.

You telephoned me on Monday, 15 June 2026 at 3:02 pm, advising that I am required to attend the Australian Federal Police Headquarters on Friday, 19 June 2026, at any time during operational hours, for the purpose of discussing certain emails transmitted by me to the Attorney-General of the Commonwealth of Australia. I confirmed my attendance during that call, and subsequently confirmed the same by text message. As agreed, I will notify you upon my arrival outside the building.

Record of Prior AFP Conduct

For the avoidance of doubt, and for the purpose of maintaining a complete and accurate procedural chronology, I place on record the following:

On 19 August 2025 at 09:11 AM, you personally led a contingent of seven (7) armed Australian Federal Police officers to my residence. During that operation, you and your officers took possession of materials belonging to me, including electronic communications and documentary records.

The AFP continues to hold the following items:

- AFP Document No. M 307584
- Item Number GT001
- Item Number GT002

These items were seized from me on the aforementioned date and time and remain relevant to matters now before, or imminently to be before, the Federal Circuit Court of Australia and the High Court of Australia.

Judicial Notification and Statutory Framework

The Courts, together with the Governor-General, the Attorney-General, the Solicitor-General, the Prime Minister, three former Prime Ministers, Interpol, Europol, and other international bodies, have been continuously apprised of all developments.

This correspondence is issued pursuant to, and in reliance upon, the following statutory and constitutional frameworks:

- Commonwealth of Australia Constitution Act — including Chapter III judicial power and the separation of powers doctrine.
- High Court of Australia Act 1979 (Cth) — governing the Court’s jurisdiction and administrative record-keeping obligations.
- Federal Circuit and Family Court of Australia Act 2021 (Cth) — including statutory duties relating to the filing, preservation, and management of documents.
- Crimes Act 1914 (Cth) — including provisions concerning the handling, retention, and disclosure of seized materials.
- Australian Federal Police Act 1979 (Cth) — governing AFP conduct, powers, and accountability.
- Evidence Act 1995 (Cth) — particularly as it relates to the admissibility, chain of custody, and integrity of seized evidence.
- Judiciary Act 1903 (Cth) — relevant to the High Court’s supervisory and appellate jurisdiction.

These frameworks collectively impose obligations upon the AFP and the Courts concerning the preservation, disclosure, and procedural handling of materials relevant to pending judicial matters.

Direction for Filing and Judicial Record-Keeping

The High Court of Australia and the Federal Circuit Court of Australia are respectfully requested to:

- Place this correspondence upon the official court file,
- Record it as part of the evidentiary and procedural history, and
- Ensure its availability for all forthcoming hearings, interlocutory applications, and judicial considerations.

This request is made to ensure the completeness of the record and the integrity of the judicial process, consistent with statutory obligations and constitutional principles.

Attendance at AFP Headquarters

As previously confirmed, I will attend the Australian Federal Police Headquarters tomorrow, Friday 19 June 2026, before 5:00 pm. In accordance with your request, I will telephone you upon my arrival outside the building.

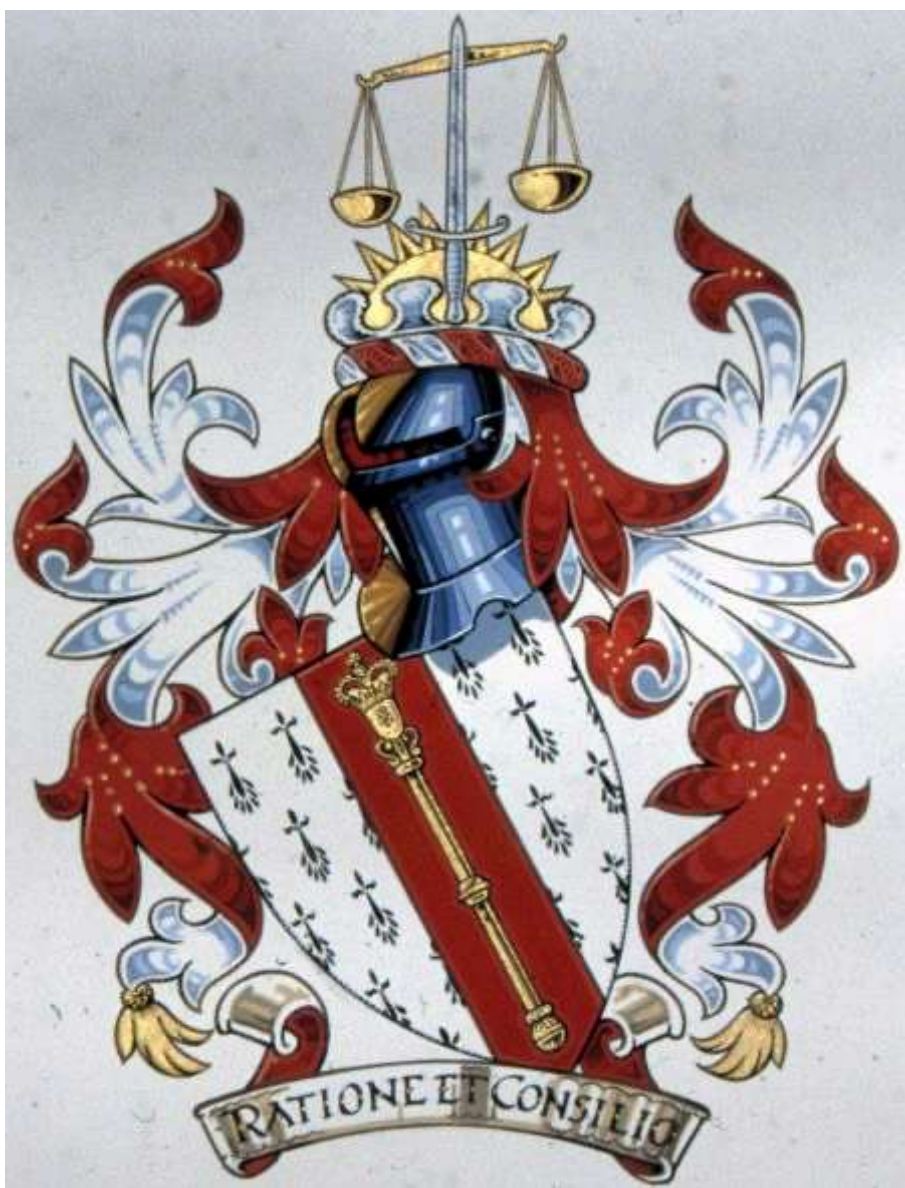
